

# **Ohio Catholic Federal Credit Union Official Drawing Rules for \$100 Gift Card Member Feedback Survey Raffle**

## **1. Promotional Period**

The \$100 Gift Card Raffle (“drawing”) begins at 9:00 a.m. Eastern Standard Time on Thursday, March 7, and ends at 5:00 p.m. Eastern Standard Time on Friday, May 3, 2019. All entries must be received during the Promotional Period. The winner will be contacted between May 6 – May 31, 2019.

## **2. Eligibility.**

Entrants must be 18 years of age or older to participate and a resident of the State of Ohio at the time of entry. Completion of the Ohio Catholic FCU Member Feedback Survey and Membership of Ohio Catholic Federal Credit Union is required. One prize per eligible person. Employees and directors of Ohio Catholic Federal Credit Union (Sponsor), their immediate family (spouse, mother, father, sister, brother, daughter, or son regardless of where they live) or members of their same households (whether related or not) of such employees and volunteers are not eligible. By entering you agree to these Official Rules and the decisions of the Sponsor, which are final and binding in all aspects.

## **3. How to Enter**

No purchase or payment necessary to enter or win. A purchase, payment or account relationship will not improve your chances of winning. All federal, state, local, and municipal laws and regulations apply. Void where prohibited.

1. Submit a completed Member Feedback Survey between March 7, 2019 – May 3, 2019.

## **4. Prizes.**

Limit one prize per individual is allowed. One (1) prize will be awarded over the course of the promotion. The prize offered in the Drawing is a \$100 Visa Gift Card. No assignment, transfer, or substitution of prize is permitted. Prizes cannot be redeemed for cash. Value of prizes will be reported on a 1099 form to IRS as taxable income.

**5. Drawing**

Prize winners names will be randomly selected from all entries collected during the promotional period. The Drawing will take place on May 6, 2019. Odds of winning depend upon the number of entries and eligible transactions. Winners will be notified by phone, or e-mail, or by mail by May 31, 2019, at the phone number on entry.

**6. General Conditions.**

By participating, participant release and agrees to holds harmless the Sponsor, and directors, officers, agents, representatives, shareholders, employees, successors, and assigns from any and all liability arising from participation in the Drawing, participation in any Drawing-related activity or receipt, acceptance, possession, use, loss or misuse of the prize. The Sponsor respects the privacy of all entrants and will not share any entrant's information with any third party unless required by law.

**7. Limitations of Liability.**

Sponsor is not responsible for any loss incurred by participant for any reason whatsoever. Winner is responsible for reporting and paying any taxes. The promotion and drawing will be governed by the laws of the State of Ohio.
