

Ohio Catholic Federal Credit Union Official Drawing Rules Remote Deposit Capture Contest

1. *Promotional Period*

The Remote Deposit Capture (RDC) Contest (“drawing”) begins at 9:00 a.m. Eastern Standard Time on Thursday, August 1, 2019 and ends at 5:00 p.m. Eastern Standard Time on Thursday, October 31, 2019 on the Ohio Catholic FCU Mobile Banking App. All entries must be received during the Promotional Period. One winner will be chosen each month and contacted within 30 days after the month in which they won.

2. *Eligibility.*

Entrants must be 18 years of age or older to participate and a member of Ohio Catholic Federal Credit Union at time of entry. One prize per eligible person. Employees and directors of Ohio Catholic Federal Credit Union (Sponsor), their immediate family (spouse, mother, father, sister, brother, daughter, or son regardless of where they live) or members of their same households (whether related or not) of such employees and volunteers are not eligible. Members are only eligible by making a deposit through the RDC feature on the mobile banking. By entering you agree to these Official Rules and the decisions of the Sponsor, which are final and binding in all aspects.

3. *How to Enter.*

No purchase or payment necessary to enter or win. A purchase, payment or account relationship will not improve your chances of winning. All federal, state, local, and municipal laws and regulations apply. Void where prohibited.

Ohio Catholic Federal Credit Union Members will automatically be given one entry form in the drawing when they:

1. Deposit a check through the Remote Deposit Capture Feature on the Ohio Catholic Mobile Banking App. Only one deposit is required for entry. Multiple deposits will not improve odds of winning prize.

4. *Prizes.*

Limit one prize per individual is allowed. Three (3) prizes will be awarded over the course of the promotion. The prizes offered in the Drawing are \$200 Visa Gift Cards. No assignment, transfer, or substitution of prize is permitted. Prizes cannot be redeemed for cash. Value of prizes will be reported on a 1099 form to IRS as taxable income. One prize will be awarded each month during the promotional period.

5. *Drawing.*

Prize winners names will be randomly selected from all entries collected during the promotional period. A monthly drawing will take place on the last day of each month.

Odds of winning depend upon entry and eligible transactions. Winners will be notified by phone, or e-mail, or by mail within 30 days of the drawing.

6. *General Conditions.*

By participating, participant release and agrees to holds harmless the Sponsor, and directors, officers, agents, representatives, shareholders, employees, successors, and assigns from any and all liability arising from participation in the Drawing, participation in any Drawing-related activity or receipt, acceptance, possession, use, loss or misuse of the prize. The Sponsor respects the privacy of all entrants and will not share any entrant's information with any third party unless required by law.

7. *Limitations of Liability.*

Sponsor is not responsible for any loss incurred by participant for any reason whatsoever. Winner is responsible for reporting and paying any taxes. The promotion and drawing will be governed by the laws of the State of Ohio.

8. *Unclaimed Prizes/Liability to Contact Winner.*

If Sponsor is unable to contact the Winner by phone, e-mail, or mail, of if prizes are not claimed within 10 days from the date of notice of winning is given, another name will be drawn and such prize awarded to the next person whose name is drawn.
